Herein referred to as "Adopter", agrees as follows:

- 1) In consideration of the adoption fee in the amount of \$\_\_\_\_\_ delivered to Paws4Life, Inc., the receipt of which is hereby acknowledged, Paws4Life, Inc. agrees to deliver unto said Adopter the following described cat/kitten:

- 2) For and in consideration of the receipt of said cat/kitten, the receipt of which is hereby acknowledged, the Adopter agrees to the following terms:
  - a. To establish contact with a veterinarian within 30 days of adoption and provide proof of this visit (if requested), and to continue the relationship on a regular basis in order to maintain the well-being of said cat/kitten through regular health checkups and to inoculate him/her with appropriate vaccinations, and to furnish proof of said inoculation to Paws4Life, Inc. (if requested).

- b. To provide proper care of said cat/kitten including a healthy diet, safe & adequate shelter (**must be kept indoors only**), love & attention, and medical attention when needed. Adopting any animal into your home is a major responsibility. It should be taken seriously and is a lifetime commitment. Adopter agrees to never, under any circumstances, abandon said cat/kitten to the outdoors, sell or relinquish said cat/kitten to a laboratory, surrender said cat/kitten to ANY shelter, pound, or facility including Animal Control. Said cat/kitten shall never be used for food, fur, or experimental purposes.
- c. **At any time during said cat/kitten's life should Adopter no longer wish to own him/her, Adopter will contact Paws4Life, Inc. In such cases, Paws4Life, Inc. retains ownership of and right to further placement of said cat/kitten. Adopter does NOT have the option of placing said cat/kitten with any other person, or facility.**
- d. To allow a representative of Paws4Life, Inc. to inspect Adopter's home before said cat/kitten is delivered and/or after adoption, and to allow a representative of Paws4Life, Inc. to remove said cat/kitten immediately should the home or surroundings be found unsuitable.
- e. To allow a representative of Paws4Life, Inc. to contact regular veterinarian as well as at least 2 personal contacts for reference checks prior to adoption of said cat/kitten.
- f. Paws4Life, Inc. makes a lifetime commitment to each cat/kitten that has come under its care, whether they are currently with us, or have been adopted into a home. And it is the very hope, priority, mission, and purpose of Paws4Life, Inc. that each cat/kitten adopted is a good match for the Adopter and home, including said cat/kitten. To ensure the happiness and well-being of said cat/kitten, and to be sure he/she is adjusting well to their new surroundings, the early stages of Adopter bringing said cat/kitten into their home will be considered the "trial period" part of the adoption process. This "trial period" will be unique with each potential adoption, as one cat/kitten may adjust faster or slower than another. Adopter agrees to keep in regular contact with Paws4Life, Inc. until ALL parties involved in the adoption process are satisfied that said cat/kitten, Adopter and

home are a good match. At that time, the “trial period” will be considered over. Periodic updates by the Adopter following the “trial period” and adoption decision are **strongly** encouraged, and Paws4Life, Inc. reserves the right to “check in” with Adopter at any time for as long as said cat/kitten is in Adopter’s possession. ~ “Check in” meaning send an e-mail or call Adopter to get an update on how said cat/kitten is doing and to make sure everything is still going well. This goes hand-in-hand with Paws4Life, Inc.’s lifetime commitment to each cat/kitten.

- 3) Title ownership of said cat/kitten shall revert to Paws4Life, Inc. at its election in the event that ANY of the above stated conditions are not met.
- 4) This instrument contains the entire Agreement between the parties and no statement, promises, or inducements made by any party or agent that is not contained in this Agreement shall be valid or binding. This Agreement may not be enlarged, modified, or altered except in writing and signed by all parties and endorsed herein.
